Joint Ventures will not be allowed.

If any bidder is found to have applied repeatedly in a single job, all his applications for that job will be rejected, without assigning any reason thereof.

The executing agency may not get a running payment unless the gross amount of running bill is 30% of the tendered amount whichever less is. Provisions in Clause (s) 7,8&9 contained in W.B. Form No. – 2911 (of Budge Budge Municipality) so far as they relate to quantum and frequency of payment is to be treated as superseded.

All materials required for the proposed work shall be of specified grade in conformity with relevant code of practice (latest revision) accordingly and shall be procured and supplied by the agency at their own cost including all taxes. Periodical quality test of material supplied by the agency and final product share to be made as per guideline of schedule of PWD/ I.S at Contractor's cost. Normally qualify control test of supplied materials/final products will be done in the Dept. Laboratory. Otherwise testing of materials/final products will be done from the outside recognize laboratory at the discretion of Engineer-in-Charge. In both the case necessary cost of testing charges will be borne by the agency.

Constructional Labor Welfare CESS @ 1% (One percent) of cost of construction will be deducted from every Bill of the selected agency. There shall be no provision of Arbitration.

General guidance for E- Tendering :

Instructions/Guidelines forelectronic submission of the tender have been annexed for assisting the contractors to participate in e-Tendering.

i. Registration of Contractor:

Any contractor willing to take part in the process of e-quotationing will have to be enrolled & registered with the Government e-Procurement System, through logging on to <https://wbtenders.gov.in> (the web portal of Budge Budge Municipality the contractor is to click on the link for e-quotationing as given on the web portal).

ii. Digital Signature certificate (DSC):

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Information Centre (NIC) on payment of requisite amount. Details are available at the Website stated in Clause.A.1.above.DSC is given as a USB e- Token.

iii. The contractor can search & download N.I.T. & Tender Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

iv. Participation in more than one work:

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If any bidder is found to have applied repeatedly in a single job, all his applications for that job will be rejected without assigning any reason thereof.

v. Submission of Tenders:

Tenders are to be submitted through online to the website stated in Clause A.1. in two folders at a time for each work one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the

Digital Signature Certificate (DSC). The documents are to be uploaded & scanned & copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats)

If there is any deficiency in the Statutory Documents the tender will summarily be rejected. Decrypted (transformed into readable formants) documents of the non- Statutory cover will be downloaded & handed over to the Tender Evaluation Committee. Summary list of technically qualified tenderers will be uploaded online.

Pursuant to scrutiny & decision of the Board of Councillors' the summary list of eligible tenderers & the serial number of work for which their proposal will be considered will be uploaded in the web portals.

During evaluation the committee may summon of the tenderers & seek clarification/ in formation of additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

1. Financial Proposal

The financial proposal should contain the following documents in one cover (folder) i.e. Bill of Quantities (BOQ). The contractor is to quote the rate (Presenting Above / Below / At par) online through computer in the space marked for quoting rate in the BOQ.

Only downloaded copies of the above documents are to be uploaded. Virus scanned & Digitally Signed by the contractor. Financial capacity of a bidder will be judged on the basis of information furnished in Section-B. Penalty for suppression / distortion of facts:

If any tenderer fails to produce the original hard copies of the documents like Completion Certificates and any other documents on demand of the Tender Inviting Authority within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies, it may be treated as submission of falsified documents by the tenderer and action may be referred to the appropriate authority for prosecution as per relevant IT Act.

Rejection of Bid :
