All materials required for the proposed work shall be of specified grade in conformity with relevant code of practice (latest revision) accordingly and shall be procured and supplied by the agency at their own cost including all taxes. Periodical quality test of material supplied by the agency and final product shall be made as per guideline of schedule of PWD/ I.S at Contractor's cost. Normally quality control test of supplied materials/final products will be done in the Dept. Laboratory. Otherwise testing of materials/final products will be done from the outside recognize laboratory at the discretion of Engineer-in-Charge. In both the case necessary cost of testing charges will be borne by the agency.

Constructional Labor Welfare CESS @ 1% (One percent) of cost of construction will be deducted from every Bill of the selected agency. There shall be no provision of Arbitration.

Bid shall remain valid for a period not less than 120 (One Hundred Twenty) days from the last date of submission of Financial Bid/Sealed Bid. i. Registration of Contractor:

Any contractor willing to take part in the process of e-quotationing will have to be enrolled & registered with the Government e-Procurement System, through logging on to <https://wbtenders.gov.in> (the web portal of Budge Budge Municipality the contractor is to click on the link for e-quotationing as given on the web portal).

ii. Digital Signature certificate (DSC):

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Information Centre (NIC) on payment of requisite amount. Details are available at the Website stated in Clause.A.1.above.DSC is given as a USB- Token.

iii. The contractor can search & download N.I.T. & Tender Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

iv. Participation in more than one work:
