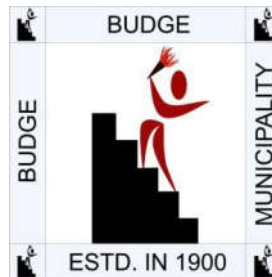

8. The EMD of the successful bidder and all tender paper costs will be transferred to the BUDGE BUDGE MUNICIPALITY Account from the pooling Account. Concerned departments will send the transfer report to Treasury regularly for entry in common collection system.
9. **Eligibility criteria for participation in the tender.**
 - i. The prospective bidder having credential during the last 3 (three) years from the date of issue of this Notice at least one work of similar nature **as a prime agency** under authority of State / Central Government, State / Central Government undertaking / Statutory Bodies Constituted under the Statute of the Central / State Government at least in the magnitude of 33.33% (thirty-three point three three percent) of the amount put to tender.  - ii. Income Tax Acknowledgement Receipt for the latest Assessment year, P.T. Deposit Challan for the year 2015-2016, Pan Card, VAT Registration Certificate are to be accompanied with the Technical Bid Documents. *[Non-statutory documents/My Space]*
 - iii. The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. 10. **No Running payment for work Will Be allowed, unless it is approved by the authority.**
11. **No mobilization advance and secured advance will be allowed.**
12. **Security Deposit:** Retention money towards performance Security amounting to 10% (ten percent) of the value of the work shall be deducted from the running account bill of the tenderer as per prevailing order. No interest will be paid on Security Deposit.

33. The eligibility of a bidder will be ascertained on the basis of the document(s) in support of the minimum criteria as mentioned in 1,2,3 above and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized. 35. **No. price preference and other concession will be allowed.**

General Guidance for e-tendering:

Instructions / Guidelines for electronic submission of the tenders have been annexed for assisting the contractors to participate in e-Tendering.

1. Registration of Contractor:

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement System, through logging on to <https://etender.wb.nic.in>, the contractor is to click on the link for e-Tendering site as given on the web portal.

2. Digital Signature certificate (DSC):

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. Details are available at the Web Site stated in Clause A.1. above. DSC is given as a USB e-Token. After the receipt of the digital signature, if the vendor feels for any assistance they can contact IT Coordinator for assistance.

3. The contractor can search & download N.I.T. & Tender Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1. using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

4. Submission of Tenders:

Tenders are to be submitted through online to the website in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

1) Login by bidder:

b) He will select the tender to bid and initiate payment of pre-defined EMD/Tender Fees for that tender by selecting from either of the following payments modes:

- i. Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI Bank Payment Gateway;
- ii. RTGS/NEFT in case of offline payment through bank account in any Bank.

2) Payment procedure:

a) Payment by Net Banking

3) Accounting and Monitoring Process:

- i) The ICICI Internet Banking will communicate to the State Government eProcurement portal all details of the transactions on daily basis.
