[Non – statutory documents] The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders without which the Technical Bid shall be treated as non-responsive).

Registered partnership Deed for partnership Firm only along with power of Attorney is to be submitted. The company shall furnish the Article of Association and Memorandum.

[Non – statutory documents]

Joint Ventures will not be allowed.

A prospective bidder shall be allowed to participate in a particular job either in the capacity of individual or as a partner of a partner of a firm. If any bidder is found to have applied repeatedly in a single job, all his applications for that job will be rejected, without assigning any reason thereof.

The executing agency may not get a running payment unless the gross amount of running bill is 30% of the tendered amount whichever less is. Provisions in Clause (s) 7,8&9 contained in W.B. Form No. – 2911 (of Budge Budge Municipality) so far as they relate to quantum and frequency of payment is to be treated as superseded.

Adjustment of price in respect of construction materials shall not be applicable. The bidders shall quote their rate accordingly.

No mobilization advance and secured advance will be allowed.

Agencies shall have to arrange land for erection of plant & Machineries, storing of materials, labor shed, laboratory etc. at their own cost and responsibility.

All materials required for the proposed work shall be of specified grade in conformity with relevant code of practice (latest revision) accordingly and shall be procured and supplied by the agency at their own cost including all taxes. Periodical quality test of materials supplied by the agency and final products are to be made as per guideline of schedule of PWD/ I.S at Contractor's cost. Normally quality control test of supplied materials/final products will be done in the Dept. Laboratory. Otherwise testing of materials/final products will be done from the outside recognize laboratory at the discretion of Engineer-in-Charge. In both the cases necessary cost of testing charges will be borne by the agency.

Constructional Labor Welfare CESS @ 1% (One percent) of cost of construction will be deducted from every Bill of the selected agency. There shall be no provision of Arbitration.

Bid shall remain valid for a period not less than 120 (One Hundred Twenty) days from the last date of submission of Financial Bid/Sealed Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.

- 7) The prospective Bidders shall have to execute the work in such a manner so that appropriate service level of the work is maintained during progress of work and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Authority. If any defect /damage are found during the period as mentioned above, the contractor shall make the same good at his own cost to the specification at par with instant project work. On failure to do so, penal action against the contractor will be imposed by the Department as deem fit. The contractor may quote his rate considering the above aspect. Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the works as mentioned above for 1 (One) year from the date of completion of the work. Provision in Clause No. 17 of Form No. – 2911 ii (of Budge Budge Municipality) shall be treated as superseded.
- 8) Site of work and necessary drawing may be handed over to the agency phase wise. No claim in this regards will be entertained.
- 9) Rs. 15,000.00 (Rupees Fifteen Thousand) only to be deposited online (NEFT/RTGS/Net Banking) through ICICI payment gateway and remaining earnest money (2% of the quoted amount) will have to be paid / adjusted before issue of work order.

- 13) Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' stated in section – 'A' before tendering the bids.
- 14) Conditional/Incomplete tender will not be accepted under any circumstances.
- 15) The intending Tenderers are required to quote the rate online.
- 16) Contractor shall have to comply with the provisions of (a) the contract labor (Regulation Abolition) Act. 1970 (b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
- 17) Guiding Schedule of Rates:- rates have been taken from P.W.D./P.H.E.(W.B.) Schedule of Rates for "Road & Bridge Works" effective from 30th August'2018 and also for "Building Works" and "Sanitary & Plumbing Works" effective from 1st November'2017 along with upto date corrigenda & addenda.
- 18) During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
- 19) The Chairman, Budge Budge Municipality reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
- 20) If there be any objection regarding prequalifying the Agency that should be lodged online to the Chairman i.e. Tender Inviting Authority within 2 (two) days from the date publication of list of qualified agencies and beyond that time schedule no objection will be entertained by the Tender Inviting Authority.

General guidance for E- Tendering :

i. Registration of Contractor:

Any contractor willing to take part in the process of e-quotationing will have to be enrolled & registered with the Government e-Procurement System, through logging on to <https://wbtenders.gov.in> (the web portal of Budge Budge Municipality the contractor is to click on the link for e-quotationing as given on the web portal).

ii. Digital Signature certificate (DSC):

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Information Centre (NIC) on payment of requisite amount. Details are available at the Web Site stated in Clause A.1. above. DSC is given as a USB e-Token.

iii. The contractor can search & download N.I.T. & Tender Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

iv. Participation in more than one work:

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If any bidder is found to have applied repeatedly in a single job, all his applications for that job will be rejected without assigning any reason thereof.

v. Submission of Tenders:

Tenders are to be submitted through online to the website stated in Clause A.1. in two folders at a time for each work one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the

Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats)

A.5.(a).) will be opened first and if found in order, cover (folder) for Non-Statutory Documents (Ref. Sl. No. A.5.(b).) will be opened. If there is any deficiency in the Statutory Documents the tender will summarily be rejected. Decrypted (transformed into readable format) documents of the non-Statutory cover will be downloaded & handed over to the Tender Evaluation Committee. Summary list of technically qualified tenderers will be uploaded online.

Pursuant to scrutiny & decision of the Board of Councillors' the summary list of eligible tenderers & the serial number of work for which their proposal will be considered will be uploaded in the web portals.

During evaluation the committee may summon of the tenderers & seek clarification/ information of additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

1. Financial Proposal

The financial proposal should contain the following documents in one cover (folder) i.e. Bill of Quantities (BOQ). The contractor is to quote the rate (Presenting Above / Below / At par) online through computer in the space marked for quoting rate in the BOQ.

Only downloaded copies of the above documents are to be uploaded. Virus scanned & Digitally Signed by the contractor. Financial capacity of a bidder will be judged on the basis of information furnished in Section-B. Penalty for suppression / distortion of facts:

If any tenderer fails to produce the original hard copies of the documents like Completion Certificates and any other documents on demand of the Tender Inviting Authority within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies, it may be treated as submission of falsified documents by the tenderer and action may be referred to the appropriate authority for prosecution as per relevant IT Act.

Rejection of Bid :
