Sealed quotations / tenders are invited by the Chairman, Budge Budge Municipality on behalf of Board of Councillors of Budge Budge Municipality from the reputed, bonafide, reliable, resourceful, well equipped, experienced in similar nature of work for demolition of unauthorized construction of the building (G+III) in the Budge Budge Municipal holding No. 182/1/8/1, M.G.Road, Budge Budge (Read as 182/1/B/1, M.G.Road, Budge Budge also), on the modus operandi with regard to WPA(P) 185 of 2021, IA No: CAN /1/2021 in respect of the Judgment passed by Hon'ble High Court, Kolkata, dt. 22/03/2022 and the exercise of the demolition work to be completed by **17/05/2022** by modern equipment and to maintain all the precautionary / safety measures for smooth demolition work and also removal / shifting the debris / demolished materials from the site to the adjoining area within a distance of 100 Meter in length.

Quotationers should quote their consolidated rate in company's letter head after proper inspection of the site and G+III building at Budge Budge Municipal holding No. 182/1/8/1, M.G.Road, Budge Budge, (Read as 182/1/B/1, M. G. Road, Budge Budge also), along with all credentials, trade license and experienced certificate in similar nature / particular of the work.

The quotation should reach to this office by 3.00PM on 12/04/2022 and will be opened on the same day at 3.30 PM in presence of the intending quotationers. The Municipality reserves all the rights to accept or cancel any or all quotations without assigning any reason whatsoever.

The specification of the stated G+III building and the terms and conditions are given below:

- 1) G+III Masonry/RCC framed structure / building with Mumpty room standing on the holding No. 182/1/8/1, M. G. Road, Budge Budge, (Read as 182/1/B/1, M. G. Road, Budge Budge also), measuring (19'-10" x 61'-7") and (6' 9" x 10'-10") along with (3'-0" x 13'-1") & (2'-10" x 61'-7") wide projection covered with brick walls in its Northern and Eastern side in all the floors, except ground floor. Total G+III structure to be demolished and ground to be leveled properly.
- 2) Steel doors and windows, railings etc to be removed.
- 3) Demolition materials/ debris like (i) Bricks, Concrete, (ii) Reinforcement /rod, (iii) Doors and windows, (iv) Rolling shutters /M. S. Grill /Collapsible Gate, and (v) All sanitary/ plumbing and rainwater pipelines etc are to be removed from the site to the adjoining area and stacking within 100 Meter from the stated holding.
- 4) Demolition of work may be carried out carefully to avoid any accident / loss of life along with shifting and stacking materials.
- 5) The work should be started within **five (05)** days from the date of receipt of the work order, and this office be informed through a letter about the commencement of work. The demolition work should be completed within **thirty (30)** days from the date of commencement of the work.

- 6) Trained/ skilled labours along with modern equipments in presence of Site Supervisor / Engineer from your end for the stated demolition work be engaged. Shifting duty of demolition work may be allowed on prior intimation to this Municipal Authority, to complete the work in time.
- 7) Step wise photographs and video of the demolition work be submitted to this office after demolition along with completion certificate and necessary bills for payment.
- 8) Earnest money @2% on the basis of "Lowest Quoted Rate" to be deposited to this office before starting of the work and this will be returned after successful completion of the work.
- 9) Delay of work will not be entertained at any cost and action will be taken against you as per law, if any violation occurs from the terms and conditions laid down in the work order , as the entire demolition process has to be executed as per order of Hon'ble High Court.
- 10) Municipality and the local police administration will assist to carry out the stated demolition work.
