

- ii) The executional work should be started within 7 (seven) days from the date of issuing work order and execution work should be completed within the completion period as mentioned above strictly, failing which a fine is to be imposed @ Rs. 1000/- ( one thousand) only per day for subsequent period regarding non completion of work except unavoidable situation.
