Each contractor is required to obtain a Class-III or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Information Centre (NIC) on payment of Requisite amount. Details are available at the Web Site stated in Clause A.1.above. DSC is given as a USB e-Token.

iii. The contractor can search & download NIQ. & Tender Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

iv. Participation in more than one work:
